**Section 1 – Introduction to your course**

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Your course – CertHE Health and Social Care- is delivered over one year of full-time study. The course provides structures in which you will be able to gain knowledge, understanding, and skills in the field of health and social care. Your course contains mandatory modules to introduce you to health studies and social care, including an understanding of skills, theories, and workplace issues in the sector. Your course aims to equip you with a range of competences relevant to the world beyond higher education (HE), provided through a placement (160 hours) that is included in the module SW1XXX Introduction to Social Care. This emphasis on employability skills prepares you to engage in lifelong learning, to consider ethics and values, and to contribute to the wider community. Your course at Royal Holloway, University of London, involves modules to the value of 120 credits. This course enables you to qualify as an Early Intervention Practitioner (HTQ). The following is a brief description for some of the most important terminology for understanding the content of this document:

*Course* – May also be referred to as 'course programme' or simply 'programme', these terms refer to the qualification you will be awarded upon successful completion of your studies.

*Module* – May also be referred to as 'course', this refers to the individual units you will study each year to complete your course. Undergraduate courses at Royal Holloway comprise a combination of modules in multiples of 15 or 30 credits to the value of 120 credits per year.

- 3) Students are able to reflect on their positionality and moral approaches in health and social care drawing on their experiences in placement and contributing to reflective assignments and group work.
- 4) Students will develop communication skills and apply them in health and social care practice settings with service users, carers, and other professionals. They will develop their academic written and oral communication skills throughout the course.
- 5) Students will develop transferable employability skills through embedded placement and a focus on life-long learning.

## Section 7 - Teaching, learning and assessment

Teaching and learning on your course is closely informed by the active research of staff, particularly in the areas of social care and social work, mental health, community health, health promotion and health inequalities. In general terms, the course provides an opportunity for you to develop and demonstrate the learning outcomes detailed herein.

Teaching and learning is mostly by means of lectures; seminars; tutorials; workshops; study groups; essay plan consultations; oral presentations and guided independent study. Assessment of knowledge and understanding is typically varied, including, for example, formal examinations, coursework, examined essays, and oral presentations. One placement of 160 hours will be undertaken.

Contact hours come in various forms and may take the form of time spent with a member of staff in a lecture or seminar with other students. These contact hours may be with a lecturer or teaching assistant, but they may also be with a specialist support staff.

The way in which each module on your course is assessed will also vary, which means you will receive a mark for it which will count towards your overall mark for the module, and potentially your award classification. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module.
